ORDER UNDER SECTION 144 Cr.PC.

1. Whereas, nationwide lockdown for 21 days as a preventive step to break the chain of spread of COVID-19 is still on in the State and in entire country;
2. Whereas, the latest situation in the neighbouring State of Assam is becoming bad and alarming;
3. Whereas, despite lockdown, there are movement of vehicles from Assam and within the district;
4. And whereas, the COVID-19 problem is a question of life and death, public health and safety and that the situation is becoming alarming on Assam side;

Now, therefore, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills Resubelpara in the interest of public health and safety and in exercise of the powers vested on me under Section 144 Cr.PC do hereby pass the prohibitory order as shown below with immediate effect.

- (i) All Inter-State border roads whether PWD road, PMGSY, MGNREGS, village road, public road etc. will be sealed;
- (ii) Inter-State movement of all types of vehicles and people will be stopped;
- (iii) All car pass and order issued to bring essential commodities mainly vegetables from Assam or within the district stands cancelled. However, carrying of essential commodities like rice, dal, salt, onion, potato etc. will be allowed with strict checking.
- (iv) Inter-District movement of all types of vehicles within the State and within the district will be restricted.

This order is passed exparte as the situation otherwise did not warrant to issue notice to all concerned and to the public.
