No.NGH/CON/COVID-19/17/2020/107, In pursuance of Govt. order vide No. No.POL.75/2020/Pt.I/29, dated 9th May, 2020 and in view of the order of the undersigned under section 144 Cr.PC vide No. NGH/CON/COVID-19/17/2020/105-A, dated 11th May, 2020, Action Plan for Operating Public Transport and Non-Transport Private Vehicles, as proposed by the District Transport Officer, North Garo Hills vide No. DTO(R)/COVID-19/2020/188/5-A, dated 11th May, 2020 is notified as shown below:

1.	Autorickshaw Passenger	There are approx. 200 nos. of autorickshaws in the District of which 50% may be allowed to ply as per the arrangement give below: 1. Monday-Vehicle No. ending with 0,2,4,6 and 8. 2. Tuesday-Vehicle No. ending with 1,3,5,7 and 9. 3. Wednesday- Vehicle No. ending with 0,2,4,6 and 8. 4. Thursday- Vehicle No. ending with 1,3,5,7 and 9. 5. Friday- Vehicle No. ending with 0,2,4,6 and 8. 6. Saturday-Vehicle No. ending with 1,3,5,7 and 9. 7. Sunday- No vehicles in this category will be allowed to ply.	However safety measures and protocols laid down by the Government should be strictly followed like wearing of face masks and maintaining of social distancing
2	Buses	There are few Buses having local permit in the District, all of which may be allowed to ply from Monday to Saturday.	Seating capacity for all vehicle categories are as follow:
3	Non-Transport (Private Vehicles)	There are approximately 8500 non-Transport (Private) vehicles including Two Wheelers in the District of which 50% may be allowed to ply as per the arrangement below: 1. Monday-Vehicle No. ending with 0,2,4,6 and 8. 2. Tuesday-Vehicle No. ending with 1,3,5,7 and 9. 3. Wednesday- Vehicle No. ending with 0,2,4,6 and 8. 4. Thursday- Vehicle No. ending with 1,3,5,7 and 9. 5. Friday- Vehicle No. ending with 0,2,4,6 and 8. 6. Saturday-Vehicle No. ending with 1,3,5,7 and 9. 7. Sunday- No vehicles in this category will be allowed to ply.	1. Autorickshaw- 50% capacity i.e.1+1. 2. Buses -50% capacity depending on total seaters. 3. Private 4 (four) wheelers 2 person+driver only 4. Two wheelers- pillion rider is not allowed

All vehicles in odd and even number formulae will be allowed to ply from 6:00 A.M. to 7:00 P.M. from Monday to Saturday. However, unnecessary going out will be restricted by Executive Magistrates, Police Officers on duty and Transport enforcement staff on daily basis.


Strict maintenance of lockdown norms will be maintained by one and all.
