**ORDER**

Dated Resubelpara, the 14<sup>th</sup> April, 2020.

No. NGH/CON/COVID-19/17/2020/60, Whereas, a positive COVID-19 case has been detected in Meghalaya, East Khasi Hills District, Shillong;

And whereas, there is an urgent need to put in place preventive measures and steps to ensure social distancing so that the pandemic of COVID-19 does not spread to North Garo Hills District and Meghalaya, by way of observance of strict protocols of the advisories issued by Government of Meghalaya, Health & Family Welfare Department and the Government of India;

Now, therefore, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills Resubelpara in exercise of the powers conferred upon me under Section 144 Cr.PC. and read together with Regulation 3 of the Epidemic Disease Act, 1897 and COVID-19 Regulation, 2020 do hereby pass the order as stated below.

1. Complete closure of all Wine shops and Bonded Warehouse under North Garo Hills District.
2. No inter State and inter district movement of people and private vehicles as passed earlier.
3. Operations of all weekly markets, regular markets, commercial and financial establishments in North Garo Hills District including those in the Meghalaya-Assam border are not allowed. However, opening of selected grocery shops dealing with essential commodities will remain the same from 8:00 A.M. to 12:00 Noon from Monday to Friday.
4. Assembly or gathering of 5 (five) or more persons in all public places, premises, commercial and residential localities beyond the individuals households is prohibited.
5. Mandatory wearing of mask will be enforced in public places.

This order will **Not** be applicable to:-

1. Security forces, Medical teams and Pharmacies,
2. MePDCL, Public Health Engineering (PHE) and Public Works Department (PWD).
3. Police and Armed Forces, Fire and Emergency Service.
4. Food & Civil Supply Department and staff.
5. Resubelpara Municipal Board.
6. Telecom, Telegraph Communication & IT Services, NIC.

7. Banks & ATMs and All Postal Services.
8. Vehicles carrying essential Commodities, food items, medical equipments or other goods, Home delivery, Community delivery vehicles with valid passes issued by the District Administration.

The Contact Tracing Team will start tracing travel history of people presently in North Garo Hills District, if there is any, who might have visited Bethany Hospital Shillong on or after 22<sup>nd</sup> March, 2020 or Bethany Hospital Nongpoh on or after 30<sup>th</sup> March, 2020. They are directed to call 1070 or District Control Room number 6009907763 or register [meghalyaonline.gov.in/covid](http://meghalyaonline.gov.in/covid).

All are directed to STAY AT HOME.

In view of the urgency of the matter, this order is being passed ex parte as the circumstance did not warrant otherwise to issue notice to the public and it shall come into force with effect from 06:00 A.M. of 14<sup>th</sup> April, 2020 and shall remain in force till 30<sup>th</sup> April, 2020 and until further order.
