
ORDER.

Dated Resubelpara, the 19<sup>th</sup> March, 2020.

- No. NGH/CON/OO/130/2014/29
1. Whereas the outbreak of COVID-19 i.e Novel Corona Virus in the country and globally is a cause of grave concern everywhere including in North Garo Hills District.
  2. Whereas, if the preventive measures are not taken at all levels there is every likelihood of spreading of Corona Virus in the district which is highly infectious.
  3. Whereas the Ministry of Health & Family Welfare, Government of India, New Delhi vide office Memorandum dated 05.03.2020 has given some advisory including avoidance of mass gathering to prevent the possible spread of pandemic disease.
  4. Whereas, in the similar manner the Government of Meghalaya has also issued certain advisory on 16.03.2020 for the residents of the State suggesting some preventive steps.
  5. Now, therefore, in view of the above mentioned facts and circumstance, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills Resubelpara in exercise of the powers vested on me under Section 144 Cr.PC do hereby issue the following order/advisory in the interest of the public of the district in particular and in the interest of all in general.
    - (i) Avoid mass gathering like meetings, training, marriage, religious gathering, sports and other events involving mass gathering etc.
    - (ii) Markets cannot be stopped but coming to market should be avoided unless it is necessary and if they come social distance should be maintained by every citizens for their own interest and for the interest of others.
    - (iii) All the Officers, VECs, NGOs, SHGs, Headmen, Nokmas should inform the District Administration about the new comers to their villages/localities be it students, employees, businessmen, labourers.

- (iv) Self/home quarantine should be done in respect of all who came from other places for 14 or 15 days initially and they should be instructed to remain indoors distancing himself/herself even from family members, friends and locality people.
- (v) People coming from outside the State should not come to hospital even if there is suspicion of contracting Corona Virus; rather it should be informed to the local PHC, CHC, Hospitals and Sub-centres.
