**ORDER UNDER SECTION 144 Cr.PC.**


1. Whereas, in order to prevent possible spread of Corona Virus in the district, several precautionary steps need to be taken and enforced.
2. Whereas, it has been brought to the notice of the undersigned that apart from many students studying in various towns and cities in other States of India, there are employees working in industries, factories, hotels and private sectors who are coming back to their respective homes and villages.
3. Whereas in view of spread of infectious COVID-19 in some States, towns and cities of India, it will be mandatory to fill up self declaration form, not only by students coming back from various towns and cities in India and abroad, it will be mandatory for all the migrant workers and employees, industries, factories, hotels and other private sectors who have come back to their home in view of situation created by the outbreak of Corona Virus in India and around the world.
4. In view of the fact that Corona Virus is infectious, self quarantine at home for 14 days is necessary for each and every person coming from outside the State and in view of the seriousness the COVID-19 problem, self quarantine at their respective home is not only necessary but also needs to be enforced.
5. Now, therefore, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills Resubelpara in exercise of the powers vested in me under Section 144 Cr.PC do hereby issue the following order as shown below.
  - (i) All those coming from outside the State whether students, migrant workers, employees of the State/Central Government, Public Sector Units or Private Sector Units need to compulsorily inform about their arrival in the district and need to mandatorily fill up in self declaration form devised by the State Government.
  - (ii) They must not come out from their respective home and mix up with other people for 14 days of their arrival and they should compulsorily do self quarantine for 14 days.



In view of the seriousness and urgency of the matter, they should comply with this order. Non-compliance of the order and wilful disobedience may lead to prosecution under relevant sections of the Epidemic Diseases Act, 1897 and relevant sections of IPC.

This order is passed exparte as the situation is urgent and in extreme necessity for public health and safety.
