ORDER UNDER SECTION 144 Cr. PC

1. Whereas, Hon'ble Prime Minister has announced 21 days Nationwide lockdown with effect from the midnight of 24th March, 2020 as preventive step to prevent fast spread of infectious corona virus;
2. Whereas, in accordance with the direction of the Ministry of Home Affairs, Government of India, Chief Secretary Government of Meghalaya has issued Press Release on 24th March, 2020 placing the whole State of Meghalaya under Curfew till 6:00 AM of 28th March, 2020.
3. Whereas, Ministry of Home Affairs Government of India vide Order No. 40-3/2020-D dated 24.03.2020 has issued certain guidelines with exemption, among other things, to shops including ration shop (under PDS) dealing with food, groceries, fruits and vegetables and milk.

Now, therefore, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills in exercise of the powers vested upon me under Section 144 Cr. PC. do hereby promulgate **CURFEW** in the entire North Garo Hills District from 6:00 A.M. of 24th March upto 6:00 A.M. of 28th March, 2020 with the exemption of essential services as shown below:

1. Medical Teams on duty
2. Wholesale & Retail Pharmacies
3. Security Forces
4. Police and Armed Forces
5. Fire & Emergency Services
6. MePDCL
7. Food & Civil Supply Department
8. Public Works Department (PWD)
9. Public Health Engineering (PHE) Department
10. Petrol Pumps
11. Resubelpara Municipal Board staff requires for essential services like sanitation, water supply.
12. Essential Services including Health Services, grocery shops selling rice, dal, mustard oil subject to given timing and restriction.

Also, movement of vehicles carrying essential commodities, security forces, medical equipments & goods vehicles are also exempted. However, Drivers and attendants of the vehicles shall be subject to medical screening as per laid down protocols.

In view of the urgency of the matter this Order has been made ex parte.


