ORDER UNDER SECTION 144 Cr. PC

WHEREAS, COVID-19 positive cases are increasing in Meghalaya and other States of the country and many people of this District came back from various States.

WHEREAS, there are reports that in some cases people entered the district recently without informing the District Administration, Police and Medical department and such people are likely to mingle with others in the district.

WHEREAS, social distancing or physical distancing has been one of the main guidelines or protocols of COVID-19 to remain safe for the spread of the disease.

WHEREAS, unless social gathering is restricted and regulated at this juncture when the COVID-19 positive cases are increasing everywhere, there is strong possibility of community transmission.

Now, therefore, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills in exercise of the powers vested in me under Section 144 Cr. PC. passed the **PROHIBITORY ORDER** in respect of social gathering as shown below;

- i) Without prior written permission all kinds of social gathering including meetings, religious gathering, wedding gathering, etc. are prohibited in North Garo Hills District.
- ii) This prohibition of social gatherings will also apply to market areas, shops, business establishment and both public and private premises.
- iii) Any individuals, groups, organizations, associations etc who violate this restriction will be treated as violation of COVID-19 direction and protocol and hence will be liable to be penalized with a fine an amount of ₹. 500/- for the first offence and ₹. 1000/- for subsequent offence.
