ORDER UNDER SECTION 144 Cr.PC.

1. Whereas, in view of the emergency situation of public health and safety due to outbreak of infectious COVID-19 i.e. of Corona Virus disease, several directions, instructions, advisory have been issued by the Central and State Government to take preventive steps including social distancing and self quarantine:
2. Whereas, unless preventive steps are taken by the authorities and the public and individuals, there is every likelihood of spreading of Corona Virus in the district and in such a medical and health emergency situation, social distancing and avoiding mass gathering is necessary.
3. Now, therefore, I Shri Sibhi C. Sadhu, IAS, District Magistrate, North Garo Hills Resubelpara in exercise of the powers vested in me under Section 144 Cr.PC do hereby prohibit all kinds of mass gathering like meetings, trainings, conference including religious and mahari gathering whether in public places or private premises in the district in the interest of public health and safety with immediate effect until further orders.

In view of the urgency of the matter, this order is passed exparte as the situation did not permit to issue notice in this regard.
