The prescribed application form (Form-I) is available in the Office of the undersigned and the application duly filled in should be reached in the Supply Branch, Resubelpara on or before 20th November 2020 after which no application shall be accepted.

The applicant must fulfill the following requirements/requisites for appointment of Govt. Nominees/ Agents.

1. He/She should be a resident of Meghalaya for a minimum period of 10 (ten) years accompanied by Scheduled Caste/ Scheduled Tribe Certificate in case of ST/SC/OBC, EPIC, Bank Passbook, Mobile No. and Aadhaar Number.
2. He/She should be literate (should be able to read and write). He/She also should be computer literate or should hire a person who should be able to update Supply Chain Management in his place.
3. Should not be the Headman/Secretary of the village including Member of the Executive Committee of the village.
4. Every applicant should have weighing scale duly certified by the Legal Metrology Department if selected.
5. Court Fee stamp of ₹ 25/- (Rupees Twenty five) only affixed in the application form. (Form I of the Meghalaya Foodgrains (PDS) Control Order, 2004)
6. 3 (three) copies of attested passport size photo of the applicant. (Photo of proprietor, if the applicant is in the name of a Firm and of Secretary, if the application is in the name of Co-operative Society/ NGO/ SHG. (One copy of photo to be affixed in the application form and 2 copies to be attached with the original Bank Guarantee.)
7. Bank Guarantee of ₹ 1,00,000/- (Rupee One lakh) only for tribals and ₹ 2,00,000/- (Two lakh) only for non-tribal applicants respectively. To be executed in Non-Judicial Stamp paper of ₹ 10/-. The validity of Bank Guarantee should be a minimum of 6 (six) months. (Original guarantee and one duplicate copy should be submitted along with the application.)
8. Availability/Possession of godown located feasibly for storage of foodgrains, should be accompanied with documentary proof and to be specified whether hired or owned.
9. Trading License for non-tribal and for tribal, if the application is in the name of Firm or Company.
10. Sales tax clearance Certificate or Exemption Certificate. Food Safety License
11. Professional tax Clearance Certificate.

Application not fulfilling the requirements or applied for the place which is not the approved centre or Expired Certificates shall be treated as invalid. Only one application from one applicant for one centre shall be entertained.
